### Access professional advice on succession planning

If handled correctly and at the right time, succession planning can provide certainty for the longer term.

Enlisting the help of a professional FAS adviser to lead discussions can remove the anxiety from those initial tricky conversations about your business vision and growth plans.

A FAS advisers can help you look at business viability, profitability and technical efficiency; and provide an independent and objective viewpoint to guide discussions.

In addition, they can explain and recommend the steps required for crofting regulatory purposes, such as the Crofting Register and decrofting, and provide options for subletting, letting, assignations or transfers.

#### Improve technical skills through free mentoring support

They can share their experience of running a farming business and practical skills such as hedge laying, drenching, shearing or lambing.

### Apply for an annual carbon audit to improve performance

Crofts with a low carbon footprint are often more efficient and profitable than similar enterprises.

Through FAS, you can apply for up to £500 worth of funding a year to commission an experienced agricultural consultant to carry out a full carbon audit of your business (VAT is covered by the participating business).

This will establish your carbon footprint, identify the sources of emissions on your croft, benchmark your performance and highlight areas you can improve operational efficiency and potentially save costs.
