- 73 million hedgerow and park trees in Great Britain.



Trees outside of woods work well in the uplands too








Benefits of Trees outside of Woods



- Landscape
- Carbon Storage
- Shelter and Shade
- Infiltration (soil, pollution and water management)
- Wildlife
- Encourage pollinators
- Fuel and Fodder





Resilience






- 40% of tree should be young (less than 20cm diameter at breast height)
- Right tree right place
- Diversity

Why decline in hedgerow trees?



- Tree diseases Dutch elm disease & ash dieback.
- Flailing hedges too often
- Felled because of perceived or actual risk to public safety.



Tree safety





- One in 10 million (deaths)
- 55 per year (A&E)
- Common Sense Risk Management of trees

- Zoning
- Tree inspection: assessing obvious tree defects - record
- Managing risk at an acceptable level: identifying, prioritising and undertaking safety work according to level of risk - record

Dealing with ash dieback




- Felling Permission
- Ancient trees and those with veteran features like hollows and rot holes are especially important for wildlife.
- Have a plan



Managing Trees Outside of Woods





- Act now
- 3/2/1/: at least 3 new trees for loss of a large tree, 2 for a medium tree and 1 tree for a small tree
- Mark wildings for retention
- Reassess hedge trimming regime
- Grow the right trees in the right places in the right ways, and give them the right aftercare
- Link with wildlife strips/water margins
- Encourage a diverse range of trees to develop a resilient landscape
- Consider pollarding
