Get funding to achieve high nutrient use efficiency

You may have heard that the Scottish **Government's Climate Change Plan Update** sets a commitment to develop "a SMART (Specific, Measurable, Achievable, Relevant and Timebound) target for reducing Scotland's emissions from nitrogen (N) fertiliser." Better nutrient use efficiency is a win-win, resulting in financial savings for your croft or farm and better protection for the environment.

The agricultural sector is dependent on N inputs, both organic and inorganic. Inefficient use of these inputs is expensive and creates N wastage, which impacts air and water quality.

The Farm Advisory Service's (FAS) soil and

nutrient management specialist advice option enables you to bring in an expert to prepare a nutrient management plan for your business. They can help you to match inputs with nutrient uptake by crops, calculate the requirements for maximum crop yield, and improve nutrient use efficiency. This can help mitigate the effects of high fertiliser costs and improve soil health.

Autumn budget implications for Inheritance Tax

Two of the changes announced will have a central effect on your succession planning decisions. What follows is a summary of a longer article available on the FAS website, with a link to the original article below.

The key terms and figures when looking at Inheritance Tax (IHT) are:

Agricultural Property Relief (APR)

Applied to eligible farmland when it is passed to the next generation - generally speaking, if farmland is being farmed then APR should apply.

Business Property Relief (BPR)

Applied to business assets (in the case of farming - tractors, machinery, livestock etc) when it is passed to the next generation.

Nil Rate Band - £325,000

The total amount of any type of assets (e.g. property, money, cars etc) that can be passed to the next generation without incurring any taxes. This is available to everyone. In a marriage/civil partnership if one person dies and only uses a portion of their Nil rate band the used amount can be transferred to their spouse.

Residence Nil Rate Band (RNRB)- £175,000

This is available when a person has owned their property, it has been their primary residence and they are leaving it to a direct descendant e.g. Children, spouse, grandchildren. A couple who are married or in a civil partnership can only have one primary residence between them.

If a person's estate is worth more than £2m (before reliefs), the relief is reduced by £1 for every £2 that the value exceeds £2 million.

Navigating peatland restoration

Currently, there is up to 100% funding available for peatland restoration projects through the Scottish Government, who have pledged £250 million to restore 250,000 hectares of peatlands across Scotland by 2030. Additional public and private funding is available, potentially offering long-term income to landowners.

Restoring peatlands can provide new grazing opportunities, reduce black loss, improve water quality and water flow for hydro schemes and fisheries. It can mitigate droughts as well as flooding, create new, greener jobs, enhance biodiversity on farms and contribute toward national efforts of greenhouse gas emissions reduction.

Peatland eligible for restoration will, in general, be 50 cm or deeper across the site and will have been altered through land management such as drainage, intensive grazing or muirburn. This can

be detected in peatlands by visible surface erosion (bare peat) and water courses turning brown with washed-out peat.

Peatlands in good condition add value to a farm. They support biodiversity, act as water storage, protect settlements and infrastructure from flooding and wildfires, and they maintain good water quality. Restored peatlands can also be safer for livestock to track across, and increased vegetation cover can enhance grazing.

Peatland ACTION manages the Scottish Government's fund for peatland restoration and provides support to farmers and crofters with their projects from planning, through delivery to ongoing management and monitoring, while ensuring current and intended land uses are considered in every project. Contact your local Peatland ACTION Officer to discuss the feasibility of peatland restoration on your farm free of charge.
